\* Per City Ordinance, 5.08.120, Right to audit statements and records:

For the purpose of ascertaining the correctness of any license tax paid, the Finance Director of the City, or any person designated by him/her for that purpose, is authorized to examine information reported by the licensee for income tax purposes and pertaining to the gross receipts, of the licensed business will be accepted when substantiated by a true and correct copy of that portion of the Federal or State income tax return. This usually means Schedule C of the return.
